## STRATEGIC INITIATIVE ACTION ITEMS - UPDATES

**USGS Projects in Nebraska**, Claire DeVaughn. Ms. DeVaughn provided an update of the Nebraska projects. Northeast NE Phase 2 – Product deliverables were received by USGS on August 4th and are currently undergoing internal review. There is no estimated date for approval at this time.

The 3DEP national hydrography program update was also provided. Over 80% of the National 3DEP Program is complete. Next major projects will involve updating the 3D National Topography Model and the 3D National Hydrography Model. # Street Centerline and Address Point Standards\*

Once that is completed, the boundary sub-committee and key stakeholders will review it. The GIS Council will also have an opportunity to review it as well. Once it has been approved, a plan to maintain and update boundaries will need to be established.
