The COVID hub site with state's dashboard and other entities has been added, including the John Hopkins as well. There was some discussion regarding the use of the ESRI hub platform to invite other entities to share applications and services on NebraskaMAP. Entities would be able to control their data. It was suggested to resurrect the NebraskaMAP Work Group to discuss this issue. Mr. Schonlau will volunteer one of his staff members to serve on the Work Group. Some agencies have been had requests for the COVID data to be CVS format. State agencies usually forwards these types of requests to DHHS.
