B. Minutes for August 1, 2000

C. Refine Vision Statement for E-Government

The group discussed the draft vision statement, goals and objectives. There were no changes to the vision statement or the three draft goals. A fourth goal to "Integrate the availability of information and services across governmental entities" was added. There were many changes to the draft objectives. A revised document is attached, which incorporates comments and suggestions.

D. Overview and Status of Related Activities

Steve Schafer reviewed existing activities relating to e-government. These include NOL's new state portal, agency comprehensive information technology plans, the NITC Technical Panel's work groups on security and e-government architecture, the e-government conference in October or November, NIS, CJIS strategic plan, GIS strategic plan, and several funding sources. Handouts included pages 26-28 of the Statewide Technology Plan pertaining to e-government, a list of draft security policies, and the charter for the e-government architecture work group. Steve Schafer also distributed copies of the Governor's priorities and goals. The priorities are lower taxes, less government, building Nebraska's economy, protecting our families, and the health, safety and success of our children. Goals include: a conservative agenda which emphasizes quality government, using technology to unify the state, decentralize operations, economic opportunity in all 93 counties, consolidate

departments, tear down the silos of government, share resources with other departments, consult people affected by government agencies, set goals, and evaluate performance.
