New Risks:

- Fremont education and governmental entities are proposing a 1 Gbps aggregated transport link from Fremont (RFP) into Network Nebraska which may have E-rate cost allocation implications for backbone and Internet as well as NN Membership cost issues for non-education entities.
- OCIO must file an E-rate Form 500 on the 2010-11 College Park Q-MOE circuit at 900Mbps and resolve before reimbursement can be sent.
- Renovo Server relocation has been postponed to July 9, 2012.
- Recent OCIO bridge performance with multipoint ESU codecs has been unsatisfactory.

Issues (Situations or events that are negatively impacting the project):

- Approval of Federal E-rate funding for 2010-11 Network Nebraska backbone has not yet been granted (\$202,775)
- A lack of Network Nebraska co-location space in Omaha is affecting Omaha Public Schools' decision to switch their Internet over to Network Nebraska.
- Gordon Roethemeyer (ESUCC Distance Education) is recommending a statewide Help Desk to report and resolve distance learning-related problems, but the 1-888-NET-NEBR number is seldom used by Nebraska K-12 entities.
